台灣林業科學稿約

壹、一般說明

- 一、本期刊為學術性刊物,歡迎全球專家學者投稿。主題包括(1)森林生物與森林生態學;(2)森林經營學;(3)育林學(含遺傳與土壤等);(4)森林保護;(5)林產利用;(6)其他與森林相關之研究。稿件類別包括(1)研究報告(Research paper);(2)研究簡報(Research note);(3)學術論述(Review article);(4)專論(Monograph)。
- 二、本期刊為季刊,每年三、六、九及十二月出版,隨時接受投稿,限未曾以任何語言在其他刊物發表之稿件。
- 三、本期刊以中英雙語並列出刊,投稿相關規定如下:
 - 1. 中文文稿
 - (1) 中文文章經審查通過後,會協助將全文翻譯成英文,投稿即代表同意後續的翻譯及出版流程。
 - 2. 英文文稿
 - (1) 若以英文投稿,作者須另行撰寫中文長摘要並放於引用文獻之後。長摘要需包含以下四個架構:背景、 材料與方法、結果與討論、結論。字數要求為:研究簡報限500-750字,其他稿件類型限1000-1500字。
- 四、投稿稿件包括圖、表與引用文獻之長度,於研究報告(Research paper)輸出不可超過12頁(或16,000字)、於研究簡報(Research note)輸出不可超過5頁(或7,000字)、於學術論述(Review article)輸出不可超過15頁(或21,750字)、於專論(Monograph)輸出不可超過20頁(或25,000字)。
- 五、請至台灣林業科學線上投審稿系統(https://www.ipress.tw/J0222)投稿,投稿流程依照線上投稿系統指引之步驟。稿件由本期刊編輯委員會送請至少二位專家學者進行同儕審查。請依稿約撰寫,否則逕退作者修改。
- 六、稿件由本刊送請至少二位相關學者專家審查,作者負有校稿的責任,確定報告正確無誤。
- 七、經本期刊接受之稿件,為配合著作權法及國際慣例,作者應簽署著作權讓與協議,並以通訊作者為代表人。

貳、文稿結構

- 一、送審文稿為中文時,首頁依序為中文題目、作者、摘要、關鍵詞、作者單位和地址(中英文並列)、通訊作者(Corresponding author)及接受審查、通過之日期(中英文並列),並加Short running title(簡題)。次頁為英文題目、作者、Summary、Key words。如屬研究報告,自第三頁起依序為緒言、材料與方法、結果、討論、結論、謝誌、引用文獻、附錄。如為研究簡報,自第三頁起依序為本文及引用文獻。請參考最近一期的台灣林業科學。
- 二、送審文稿為英文時,首頁依序為英文題目、作者、Summary、Key words、作者單位和地址(中英文並列)、 通訊作者與接受審查、通過之日期(中英文並列),並加Short running title(簡題)。次頁為中文題目、作者、 摘要、關鍵詞。如屬研究報告,自第三頁起依序為INTRODUCTION、MATERIALS AND METHODS、 RESULTS、DISCUSSION、CONCLUSIONS、ACKNOWLEDGMENTS、LITERATURE CITED、EXTENDED ABSTRACT、APPENDIX。如為研究簡報,自第三頁起依序為TEXT、LITERATURE CITED、EXTENDED ABSTRACT。
- 三、本刊不鼓勵序列報告(Serial titles),文稿題目以30字為限。英文題目除冠詞、連接詞、前置詞外,各字第1個字母均需大寫。
- 四、作者中英文姓名之右上角以縮小數字標示服務單位及通訊作者之註記。作者的英文姓名需列全名,名在前,姓在後。複姓複名者,二字間用"-"相連,作者若為兩人以上,均以半型逗號連接。
- 五、中英文摘要以500字為限。中英文關鍵詞以5字(詞)為原則。
- 六、引用文獻規格:
 - 1. 引用文獻請全部以英文表示。
 - 2. 文稿中文獻引用,請列姓氏與年代,以西曆表示。若有多篇文獻時,以年代先後順序排列之;同一年份 內之多篇引用文獻,則按筆劃或a、b、c順序排列。
 - 3. 引用文獻之書寫方式請參照下列之規定:
 - (1) 引用自期刊文獻,依序為作者姓名、年代、題目、期刊名、卷期、頁數等次序列明。
 - 範例: ① Deng SL, Hwong JL, Chang YH, Hsu JT. 2015. Feasibility of natural regeneration of Casuarina in Sihhu lowland coastal wind breaks. Q J Chin For 48(3):205-20. [in Chinese with English summary].

- (2) 引用自書籍者,依序為作者姓名、年代、文章題目、書名、編著者、頁數。
- (3) 引用自研討會所發表的論文(conference paper)、專集(proceedings)、會刊、會議記錄等,請依作者姓名、年代、題目、會議名稱、召開會議機構、會議地點及日期。

- (6) 其他有關西文文獻之引用請依據Scientific Style and Format, sixth edition (1994)之規範,引用格式採 Name- Year系統。期刊名稱請用縮寫,縮寫方式以學術界通用為準,或參閱International Standard ISO 4-1984(E)。

七、圖、表格式:

- 1. 圖、表請另頁製作,附於文稿之後。
- 2. 表格僅列橫線,無縱線。表中有註解者,需以1)、2)、……等上標於右上角,並於表格下依序解釋。
- 3. 表格以一頁能登載為原則,如超過一頁範圍,次頁請註明為續表,各項標題亦應重複敘明。表格橫跨2欄時,其所能容納的文字及空白。
- 4. 照片解析度以縮小可判讀為宜(300 dpi);多幅照片請自行併版;顯微照片須加比例尺大小。
- 5. 圖稿內縱橫軸之標題第一個詞字首大寫。縱軸之標題均為由下至上,橫軸由左至右,居中排列。圖稿之符號說明,應列於圖說中。
- 6. 圖稿內縱橫軸之標題、單位與表內項目及內容,均以英文書寫表示,地名翻譯時,用括號將中文列出。
- 7. 圖表說明及文章內引用均請用英文。圖表以 "Fig. I" 或 "Table I" 等順序表示。照片與圖均以 "Fig. " 標示。

參、格式規定

- 一、來稿請以.docx或.odt格式撰寫,文稿之天、地、左、右須留白3公分,2倍行高、連續行號,並於每頁下方 註記頁碼。文稿段落與段落間留一空白行,各段落一律向左對齊,起頭需留二個字元。
- 二、文稿請使用相同字體、相同字形。文稿內之阿拉伯數字、括號一律用半型字。
- 三、中、日文部份所有標點符號皆用全型字,其後不需留空白格。
- 四、文稿之主、次標題,以編號方式排序表示:(一);1.;(1)。
- 五、文文稿中第一次出現動物、植物名應列其學名,學名請以命名法規表示。
- 六、數字、單位、符號及記號表示:
 - 1. 除習慣用語如 "星期六" 外,在表示數量時,均應使用阿拉伯數字。
 - 2. 長長度、面積、體積及重量單位,一律使用公制,依照 SI (國際標準單位)之規定。
 - 3. 常見符號、單位如%、cc、mL、cm、g、s、ha、ppm、pH等,請使用半型字,不必另用中文。統計符號 依常用之統計名詞縮寫表示。化學元素符號有上下標記者,應於文稿頁留白處註明。
 - 4. 表示一系列的數據時,只需在最後一項寫上單位(如3、6 和 8 cm);表示範圍時亦同。

Notice to Contributors

I. General

- The Taiwan Journal of Forest Science is an academic publication that welcomes contributions from around the world. The journal covers all aspects of forest research, both basic and applied, including Forest Biology and Ecology, Forest Management, Silviculture (include genetics and soils), Forest Protection, Forest Products Utilization and others forest related research. Manuscripts acceptable to the journal include (1) research papers,
 - (2) research notes, (3) review articles, and (4) monographs. A research note differs from a research paper in its scope which is less-comprehensive, yet it contains important information. In other words, a research note offers an innovative perspective or new discovery which is worthy of early disclosure.
- This journal is published quarterly every March, June, September, and December. Each manuscript to
 the submission and peer-review system of *Taiwan Journal of Forest Science* (https://www.ipress.tw/J0222).
 High-quality original photos should be sent by e-mail as well. Manuscripts are limited to original work
 previously unpublished in any other journal.
- 3. This journal is published bilingually in Chinese and English. Upon acceptance, articles in Chinese will be translated into English. Additionally, for submissions by international scholars, the author is required to write an English extended abstract. The journal will assist in translating it into a Chinese extended abstract. It must include the following sections: Background, Methods, Results and Discussion, Conclusion. The word limit is as follows: Research notes are limited to 500-750 words, while other types of manuscripts are limited to 750-1,000 words. Submission implies consent to the subsequent translation and publication processes.
- 4. The length of a submitted manuscript, including figures, tables, and references, should not exceed 12 printed journal pages (or 6,000 words) for a research paper and 5 pages (or 2,500 words) for a research note. A review article should be limited to 15 pages (or 7,500 words), whereas a monograph should be no less than 20 printed pages (or 10,000 words).
- 5. The submitted manuscript will be sent to at least 2 scholars or scientists in the field for peer review and comments. The reviewed paper will be reexamined by the Editorial Board. Authors are responsible for proofreading the galley (printer's copy) to ensure accuracy. Free copies of reprints will not automatically be sent to the corresponding author upon publication in the journal. The full contents of the Taiwan Journal of Forest Science are available on the website of the institute at www.tfri.gov.tw. Authors can access the contents by clicking on the library and publication section of the website if desired.
- For manuscripts submitted for publication in the journal, a copyright assignment must be signed by the corresponding author, authorizing the transfer of the copyright to the journal in accordance with copyright laws and international conventions.

II. Structure of the manuscript

- 1. The first page should contain the English Title, Author(s), Summary, Key words, a short running title, affiliations and addresses, corresponding author, and the dates of peer review and acceptance, as well as the full title of the author's organization(s) and address(es). From the second page on, the paper should be organized in the sequence: INTRODUCTION, MATERIALS AND METHODS, RESULTS, DISCUSSION, CONCLUSIONS, ACKNOWLEDGMENTS, LITERATURE CITED, EXTENDED ABSTRACT and APPENDIX. A note only includes: TEXT, LITERATURE CITED and EXTENDED ABSTRACT.
- 2. The journal discourages serial-titled publications. Titles should be limited to 30 words. The first letter of each word of the title except articles, conjunctions, and prepositions should be capitalized.
- 3. An author's full name should be given, with first name followed by the surname (a middle initial can be included if that is the normal way an author presents his or her name). If the manuscript has 2 or more authors, the names should be separated by commas.
- The summary of an article should not exceed 500 words. No more than 5 phrases are suggested for the list of key words.
- 5. Rules for citing literature are as follows:
 - (a) Citation in the text should list the surname(s) and the year of publication for references with 1 or 2 authors; otherwise list the first author's surname and et al. with the year of publication. If 2 or more reference are cited together, list them sequentially by publication year. List more than 1 reference with the same publication year in alphabetical order (Smith 1979, Jones and Smith 1980, Jones et al. 1980, Albert 2000).
 - (b) The LITERATURE CITED should follow these rules:
 - i. The citation should be listed in this order: authors' names (if there are more than 6 authors, list the first 6 authors and et al.), year of publication, title of the work, name of the journal, volume, issue, and page numbers. For example:

- ii. When citing from books, the editor(s)/author(s), year of publish, book title and page numbers should be noted. If citing from conference papers, proceedings, meeting notes or reports, then the name of the conference or meeting, the organizer, location and date should be included. For example:
 - A. Hamrick JL, Godt MJW, Murawaki DA, Loveless MD. 1991. Correlation between species traits and allozyme diversity: implications for conservation biology. In: Falk DA, Holsinger KE, editors. Genetics and conservation of rare plant. New York: Oxford Press. p 75-86.
 - B. Allen RG, Pereira LS, Raes D, Smith M. 1998. Crop evapotranspiration. Guidelines for computing crop water requirements. FAO Irrigation and drainage paper 56. Rome: Food and Agriculture Organization.
 - C. Samways MJ. 1994. Insect Conservation Biology. Chapman & Hall, London, 358p.
 - D. Sun SK, Huang CW. 1996. Plant fusarium diseases in Taiwan. Taichung, Taipei: Shih Wei Press. 170 p.
- iii. When citing from doctoral dissertations or master theses, the name of the university should be included. If government publications are cited, the name of the offices involved should be included. For example:
 - **Ritzmann RE. 1974.** The snapping mechanism of Alpheid shrimp [dissertation]. Charlottesville, VA: Univ. of Virginia. 59 p. Available from: Univ. Microfilms, Ann Arbor, MI; AAD74-23
- iv. Citation of a webpage should also include the web address and the date accessed. For example: TFRI. 2010. Taiwan Forestry Research Institute. Available at https://www.tfri.gov.tw/en/News.aspx?n=7589&sms=12385 Accessed 2023 September 1.
- v. The name of the journal cited should be abbreviated. The manner of abbreviation should be preferentially in accordance with that listed on the website https://guides.lib.berkeley.edu/bioscience-journal-abbreviations/a-b. If the site hasn't got the particular journal you're inquiring, then the website https://library.caltech.edu/reference/abbreviations/ should be consulted and followed.
- 6. Construction of tables and figures:
 - (a) Tables and figures should be prepared on separate sheets and attached to the end of the manuscript.
 - (b) Tables should consist of only horizontal lines; all vertical partitions should be eliminated. If remarks or notes are required in the table, marks should be placed on the upper right corner with small 1), 2) ... etc. These should be listed in the sequence of appearance under the table.
 - (c) Tables should be limited in size to what can be printed on 1 page. If exceeding 1 page, then a note indicating continuation of the table is required on the next page with the item headings delineated again. When the tabular materials cross 2 printed columns, the contents in words and spaces need to be planned carefully before making the table.
 - (d) Photographs should be clearly legible after reduction(300 dpi). Micrographs should include bars indicating the scale of magnification.
 - (e) All axis labels should begin with capital letters. The ordinate label should read from bottom to top and that of the abscissa should read from left to right; both should be centered. Symbols used in the graphs should have legends explaining them. All fonts in the graphs should be the same.

III. Format

- 1. Please write manuscript in .docx or .odt format. The printed page must be double spaced and there should be 3-cm margins on the top, bottom, left, and right of the text. Page numbers should be on the bottom of the page.
- Submitted manuscript should be printed in uniform character sizes. There is no need to differentiate paragraph, title, subtitle or contents by using large or small characters, blanks, or centering.
- 3. When citing figures and tables in the text, use sequences such as "Fig. 1" and "Table 1" or (Fig. 2) and (Table 2). Both graphs and photos use the "Fig." designation.
- 4. When the subject of study is an animal or plant species, the first appearance of its name should be accompanied by the scientific name in italics.
- 5. Years in the text and in cited references should universally use the Julian calendar.
- 6. Expressions of numbers, units and symbols should follow the rules below:
 - (a) All numerals and quantities should be expressed in Arabic numbers, except as the first word in a sentence.
 - (b) Length, area, volume, and weight should be expressed in customary CGS units or in accordance with SI (Systeme Internationale) units.
 - (c) Statistical symbols should follow conventional abbreviations. Chemical symbols with sub- or superscripts should be noted in a blank space in the context of the manuscript.
 - (d) When a string of data or expression of ranges is presented, units should only be added at the end: 3, 6, and 8 cm.
