The government should further improve the ideological understanding to create a "maintain the campus environment, improve the quality of education" atmosphere in the whole society. The relevant government departments should make great efforts to remove the "cancer" around the campus, purifying the education environment and forming a normal, long-term mechanism to prevent the unhealthy places to re-burning. The competent department of education should strengthen supervision and continuous supervision. Also they should summarize the campus security management innovation work model to promote.

### 3.2. School Establishes Effective System

University leaders should take the lead to set up a school-level coordination group for campus public security management to ensure smooth channels with government organs, and formulate work plans on campus and periodically supervise. The security department of the university should take the lead and all aspects participate in an all-round way to form a good atmosphere of teachers and students and staff co-management work system.

### 3.3. Teachers Are Responsible for Ensuring the Implementation of Measures

The counselor teachers should use the theme class meetings to strengthen the law and discipline of all students, as also as fire prevention, anti-fraud, employment safety and other special education. At the same time, teachers should make good use of the backbone of students to collect and find students in the unusual dynamic. Teachers in the classroom should be aware of strictly attendance. If there is the absence of students, teachers should inform counselors in time to prevent private going out or causing serious public security incidents.
