Introduction to Authors

- 1. Manuscripts should conform to "Vancouver Style" (Uniform requirments for manuscripts submitted to biomedical journals. British Medical Journal 1988;296:401-5)
- 2. Three copies of the manuscript, and three full sets of illustrations, should be sent prepaid to: Society of Emergency and Critical Care Medicine, Taiwan, R.O.C. No. 11, Ching-Tao West Road, 8F-1, Taipei, Taiwan, R.O.C.
- 3. The manuscripts should include: complete name, telephone number, facsimile number, and the hospital departmental or institutional affiliations of the authors, and signatures of all authous on a permission for publication sheet.
- 4. Manuscripts, including references, should be typed on one side of A4 (30×21 cm) paper with double spacing and 2.5 cm margins.
- 5. The manuscript should be arranged as follows: title page, abstract, text, acknowledgments, references, legends and finally figures and tables. An abstract in Chinese should be included on the last page for any text written in English and vice versa. Each section should begin on a new page. The pages should be numbered consecutively. The first page should contain the title of the article. The title should consist of less than 40 words in English or 15 words in Chinese.
- 6. Units of measurement should be expressed using the metric system whenever possible, and may be abbreviated when used with numbers. The first time an uncommon abbreviation appears in the text, it should be preceded by the full name for which it stands.
- 7. An abstract of an original article should be less than 250 words and that of a case report should be less than 100 words. Two to six key words should be placed below the abstract.
- 8. References should be listed in consecutive, numerical order as they appear in the text.

 References are to be typed double-spaced on sheets separated from the text. Sample formats are as follows:
 - (1) Standard journal article (list all authors when six or less; when seven or more list only the first three and add et al).
 - Klein LW, Richard AD, Holt J, Smith H, Gorlin R, Teichhoiz LE. Effects of chronic tobacco smoking on the coronary circulation. J Am Coll Cardiol, 1983;1:421-6.
 - (2) Books and other monographs. Schiebler GL, Van Mierop LHS, Krovetz LJ. Diseases of the tricuspid valve. In: Moss AJ, Adams F, eds. Heart disease in infants, children and adolescents. Baltimore: Willams & Wilkins, 1968;134-9.
- 9. Illustrations are to be sharp, glossy black and white prints. 12.5 × 17.5 cm in size. If an illustration in full color is to be considered for publication, the author must bear the full costs of color publication. Each illistration or photograph should have a label pasted on the back, indicating the figure number, names of the authors, and the top of the figure. Photographs of patients in which the subject is identifiable must be accompanied by written permission for publication.
- 10. The Editors have the right to correct the manuscript, determine the time of publication and arrange the order of publication.
- 11. The copyright of the manuscript will thereby belong to the Society if it is accepted.
- 12. A disc of the corrected manuscripted must be sent to the Society after it is accepted.
