- 三、 文稿內容以資策會大五碼(Big-5)或統一碼(Unicode)繁體漢字集 為準,簡體中文請自行轉換字碼;如遇電腦缺字,請參考中文全字庫 (www.cns11643.gov.tw),依國家標準中文交換碼(CNS11643)造字 (或附造字檔)。
- 四、本刊長期徵稿,來稿隨到隨審。來稿經編輯委員會初審通過後,送請專家學者進行雙匿名審查。稿件經編輯委員會通過後始予刊登,無法刊出之稿件將儘速通知作者。
- 五、 來稿務必包含中英文之題名、摘要(五百字以內)及關鍵詞(五個以內);並附真實姓名、簡介(現職服務機構及完整職銜)及聯絡方式(地址、電話、傳真與電子郵件)。
- 六、 請勿一稿兩投。來稿若曾以其他語文或不同之形式發表,應取得相關 授權同意,並予以註明。文稿若涉第三人著作權部分(如圖片及較長 之引文),請自行取得相關授權同意;若有抄襲、剽竊或重製等侵權 行為,一切法律責任概由作者負擔,與本學刊無關。
- 七、 來稿未獲審查通過者,恕不退還。通過者,將於本學刊及本學刊之電 子期刊刊載全文;來稿刊出後,一律贈送作者該期學刊二本,不另致 酬。

- 八、 凡已刊出之文稿,本學刊均享有著作財產權,並得將文稿內容轉載於本學刊或臺灣師範大學所授權之網站及資料庫;日後除作者本人將其個人著作集結出版外,任何目的及任何形式之重製、轉載或翻譯,皆須事先徵得本學刊同意,始得為之。

Submission Guidelines

- 1. Taiwan Journal of East Asian Studies (TJEAS) is a biannual academic journal and has published regularly since June, 2004. This journal is based on Humanities and Social Sciences as the context of the researches. It aims to establish a base for dialogues between East Asian civilizations and other civilizations that allows for a better understanding of the core values of East Asian civilizations. This biannual publication is open to the public, and papers from diverse fields and specializations are welcomed.
- 2. Submissions should be focused on a research thesis, with supporting research data, discussion and comment. Book reviews, and related research notes are also welcome. We accept submissions written in Chinese and English.

Please kindly follow the *Journal* "Submission Format":

- (1) 10,000 to 30,000 words for submissions written in Chinese.
- (2) 15 to 25 pages for submissions written in English.

Translated papers should be only from academic publications, and should incorporate footnotes and analytical discussions.

For other kinds of submissions, Chinese texts should under 10,000 words; English texts should be under 10 pages, including footnotes, annotations, and references.

- 3. The typesetting should be in Big-5 or Unicode in traditional characters, instead of simplified characters. In case of missing characters, please refer to www.cns11643.gov.tw.
- 4. Articles may be submitted for publication in *Taiwan Journal of East Asian Studies* at any time. All submissions must pass a preliminary review by the Editorial Board before being sent to scholars in relevant fields for double-blind review. The Editorial Board will make final decisions about publishing submissions based on the results of the peer review process. All authors will be notified once a decision has been reached.
- 5. Please kindly send submissions with title, abstract (maximum 300 words), keywords (maximum 5 words); author's name, brief introduction (position and title), and contact information (address, contact number, fax or e-mail address).
- 6. Please avoid multiple submissions. If the article has been published in other languages or forms, authorized approval should be acquired with

acknowledgement. Also, kindly acquire related approval concerning the copyright of third party data (like graphs or citations). All authors are liable for plagiarism and copyright infringement. The *TJEAS* shall not be responsible in any circumstance.

- 7. Submissions are not returnable if without notice of acceptance. For successful applicants, full text will be published both in the *TJEAS* publication and the electronic version. Authors will receive two copies of the recent publication with no additional remuneration.
- 8. We reserve the copyrights of all published articles, which are eligible to be republished on website, and database pending authorization by National Taiwan Normal University. Any duplication or translation of the articles in whatsoever form must have prior approval from *TJEAS*.

- 一、 文稿一律以橫式書寫。內文字型,中文以「新細明體」、「標楷體」(引文)為準,英(西)文以「Times New Roman」為準。
- 二、 文稿請按「題名」、「作者/譯者」(附簡介)、「摘要」(中英文)、「關 鍵詞」(中英文)、「節次標題」(壹、貳、參……)、「段落標題」(一、 二、三……)、「內文」、「條目」(1、2、3……)、「圖片/表格」、「圖 說」、「引用書目」之順序撰寫。
- 三、 文稿如子目繁多,請依各級子目次序標明,其次序為:壹、一、(一)、 1、(1)、甲、(甲)(此處左右括號為半形)。
- 四、 英文文稿一律使用半形標點符號,請依照*The Chicago Manual of Style: The Essential Guide for Writers, Editors, and Publisher* (Chicago: University of Chicago Press, 2017, 17th ed.)撰寫。

古代文獻可不標出版資訊,但請依中國朝代序昇冪排列;相同朝代者,請依作者姓氏筆劃數序或字母序昇冪排列;

四、 引用書目所列之作者、名稱、年份及版本,請與內文、註腳保持一致。

Manuscript Guidelines for Articles

I. Text

- 1. Submissions in English should be written in Times New Roman font.
- 2. Please follow (1) the title; (2) author/translator; (3) abstract; (4) keyword; (5) section heading; (6) paragraph heading; (7) text; (8) graph/table; (9) illustration; (10) cited works; (11) bibliography accordingly.
- 3. English articles should refer to *The Chicago Manual of Style: the essential guide for writers, editors, and publisher* (17th ed., Chicago: University of Chicago Press, 2017).
- 4. All titles should be italicized and initially capitalized, whereas articles, prepositions and conjunction are exception. Please use semicolon to separate titles from subtitles, and capitalized the initial subsequently. In case of capitalization influences the meaning, keep the original font unchanged.
- 5. Journals, theses or dissertation, journal articles, books or conference papers should indicate with "-" or '-'.

 Journals, theses or dissertation, journal articles, books or conference papers in English with phonetic symbols should refer to the original text or academic praxis.
- 6. Indent the first line of the paragraph and indicate in Time New Roman font.
- 7. For quoting words and phrases, indicate in single quotes; for quoting speech, the final punctuation marks before close-inverted comma; for proper noun or particular expression, the final punctuation marks after close-inverted comma. Use square brackets [--] or [—] for quotation; ellipsis[...] for omission.
- 8. All footnotes should appear beneath the article.
- 9. The first appearance of the translated name should indicate together with its original one. For Chinese, Japanese and Korean transliteration, please refer to academic praxis.
- 10. For graph, table or picture, please state clearly the source. The title should appear on top of the table, whereas the illustration below. For picture, both the title and illustration should appear at the bottom of the picture.

- 11. Dissertation should indicate citation that quoted from the particular works.
 - A part from cited works, a bibliography is also recommended.
- 12. If quote from different edition, please specify the edition quoted from.

II. Works Cited

- 1. Serial numbers are unnecessary for all entries. Please follow the same format as that of the footnotes.
- 2. Entries in English should be listed apart from Chinese and Japanese.
- 3. List all entries in alphabetical order by last name of the author. Article completed by two authors, list both authors alphabetically. If author publishes two articles or above within a year, indicate the year of publication in sequence. Ex: 1953a, 1953b.
- 4. Author, title, year of publication and edition in the works cited page should in accordance with the text and footnotes.
- 5. For bibliography, follow the format as that of the works cited page

Academic Ethics

Editors

Editors should:

- 1. If a submission is deemed appropriate in topic, content, quality, and format it will be sent out to two reviewers.
- 2. Reviewer panel recommendations shall be made based on known ideal candidates. In addition, administrators shall take into account contributor-reviewer conflict of interest (e.g., advisors, peers, and collaborators) to exclude unsuitable reviewers.
- 3. Upon acceptance of an article, authors will be asked to complete a transfer of the copyright of the article to National Taiwan Normal University. Accepted manuscripts should be edited by authors in accordance with the format detailed in "Manuscript Guidelines for Articles".

Reviewers

Reviewers must:

- 1. Manuscripts are reviewed in a double-blind fashion. The name of the author is anonymous to the referee(s), while the referee(s) is anonymous to authors.
- 2. Unless otherwise specified, *Taiwan Journal of East Asian Studies* expects editors and reviewers to handle all submissions in confidentiality. Reviewers are expected to offer reports objectively.
- 3. Reviewers are asked to complete their reviews within one month of receipt and to provide clear reasons for judging the submission to be in one of the following four categories:
 - (1) Accept
 - (2) Minor Revision

- (3) Major Revision
- (4) Reject

Authors

Authors should ensure that:

- Submission of an article implies that the work described has not been published previously, that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities.
- 2. All manuscripts should be submitted via the online system: http://ojs.lib.ntnu.edu.tw/index.php/tjeas
- 3. Where material is taken from other sources (including their own published writing) the source is clearly cited and that where appropriate permission is obtained.
- 4. All authors must have materially participated in the research and/or article preparation. Only articles in Chinese and English are solicited.
- 5. When an author discovers a significant error or inaccuracy in his/her own published work, it is the author's obligation to promptly notify the editorial board and cooperate with the editor to retract or correct the paper. Authors of reports of original research should present an accurate account of the work performed as well as an objective discussion of its significance.

Others

- The Journal is funded by the Research Institute for the Humanities and Social Sciences, Ministry of Science and Technology and the Research and Development Division and College of International Studies and Social Sciences of the National Taiwan Normal University. Publications with commercial intent shall be rejected.
- 2. The instance of a breach of academic ethics, the Journal shall convene

a review panel meeting to determine the best course of action.
