# 危機管理學刊

## 投稿說明

- 1. 本學刊要求具有原創性,相關於運輸安全、企業安全、公共安全、國家安全、資訊安全、職業安全與衛生、整合評估研析以及工業安全與管理等之危機管理論文。凡投寄之稿件須以不在其它期刊刊登者為限。稿件請以電傳方式到本學刊總編輯:崔海恩博士 sec@cmst.org.tw。
- 2. 如經接受,校對工作將由作者負責。論文長度以盡量不超過12頁篇幅為準。超出之頁數,需加收審稿費每頁壹仟元。作者需付本學刊刊登費每篇壹仟捌百元。作者如需論文抽印本,每份工本費80元,數量以10本為一訂購單位。
- 3. 稿件宜簡潔,且合乎下列格式:
  - (1) 文字:稿件應以中文或英文撰寫,內文中文字體以細明體 11 點字,英文字體以 Times New Roman 11 點字為準,並附不超過 150 字之中文及英文摘要,以及 5 個以下之關鍵詞。
  - (2) **打字**:稿件以 MS Word 編輯軟體或與其相容之軟體為限。 橫式雙欄打字為原則,列與列間應固定 18 點之間隔,用紙大小以 21 公分 X 29.7 公分(A4 規格)為準,上、下各留邊 2.2 公分,左、右各留邊 2.2 公分。裝訂邊為左邊 0.5 公分。
  - (3) **題目、作者:**論文題目宜簡明,中文標題為細明體 20 點粗體字;英文標題為 Times New Roman 20 點粗體字。作者姓名細明體 14 點粗體字列於論文題目之下方。
  - (4) **章節及小節標題:**論文之各節標題應置於列之左方位置,中文字體以細明體 12 點粗體字, 英文字體以 Times New Roman 12 點粗體字為準。小節標題則應從文稿之左緣開始,中文字 體以細明體 12 點字,英文字體以 Times New Roman 12 點字為準。
  - (5) **参考文獻**:僅限於在文中引據之論文、書籍等,文獻之編號按論文引據出現文中之順序。 例如:

### **INSTRUCTIONS FOR AUTHORS**

- 1. An original, creative journal paper, related to the field of Transportation Safety, Enterprise Safety, Public Safety, National Security, Information Safety, Occupational Safety & Health, Integration Assessment, and Industrial Safety & Management is sincerely welcomed for publication of Crisis Management Society, Taiwan (CMST). All submitted papers must be previously unpublished. All research paper submittal should be email to Dr. Hess Tsuei, email address:sec@cmst.org.tw
- 2. It is author's responsibility to submit the final revised paper. The submitted paper is limited within 12 pages, and an editorial fee will be charged NT 1,800 (US\$ 60) for accepted paper. Each additional page will be charged NT 1,000 (US\$ 35) for extra editorial work. Each reprint will be charged NT 80 (US \$2.6), and ordering unit is 10 reprints.
- 3. The format of submitted paper should be followed:
  - (1) **Submission**: All manuscript should be written in English or Chinese, Times New Roman with size 11. An abstract not exceeding 150 words in length should be included. It should present a brief and factual account of the content and conclusion of the paper. 5 keywords or less are required.
  - (2) **Typing**: 18 pt spacing, two columns on single side of a 21cm X 29.7cm (A4) paper, with all edge margins of 2.2 cm, and 0.5 cm on left side for book binding.
  - (3) **Title, author:** the title should be typed with Times New Roman with size 20 bold-faced. The author should be Times New Roman with size of 14 bold-faced.
  - (4) **Subtitles**: all subtitles should be arranged from left side in Times New Roman with size 12 bold-faced. The sub-subtitle should be typed in Times New Roman with size 12.
  - (5) **Reference**: References should be numbered [1], [2] consecutively in the text and listed at the end of the paper. The following format should be used:
